The agency must provide direct health and/or human services, benefits, or assistance and be nondiscriminatory in service delivery.

- If your selected organization does not meet the above requirements or your gift is less than \$100, your designation will be invested in United Way of Lancaster County's Community Impact Fund.
- A 15.8% administrative processing fee will be deducted from payments made to designated agencies.
